- 2. The tenderers/Firms should upload following documents otherwise tender shall be rejected:

  - e, GSTIN Registration.
  - F, Income Tax Return
  - g. Relevant CDR/DD
- 3. The approved rates shall be valid for a period of one year from the date of issuance of the rate contract. The suppliers shall be received by the concerned strictly in accordance with the quality/specification as per terms and conditions of the concerned e-NIT
- 4. The purchase of material should be strict to the allotted/ availability of funds only without creating and liability.
- 5. Any CDR/FDR pending in the Department will not be accepted towards the current e-NIT.
- 6. Conditional tender shall not be entertained or accepted.
- Successful tenderers shall have to enter into formal agreement deed with the department to on non
  judicial stamp paper under rules and in case failure in executing the agreement; the CDR shall not be
  released.
- 8. Successful tenderer /supplier of previous year shall have to obtain a satisfactory performance certificate /NOC from the concerned Drawing and Disbursing officers /order placing authority failing which their tender shall not be entertained.
- 9. Rate contract shall out rightly be rejected and replacement by the supplier on his own risk & cost without any additional charges.
- 10. Only the registered constrictors/suppliers experienced in the job will be eligible for uploading tenders.
- 11. Un-casted CDR/FDR shall not be released.
- 12. The CDRS of the un-successful contractors shall be released strictly after rate contract is fixed or, in case failure proper response or re-tender for supply, the CDR's will be released instantly.
