FRESH e- TENDER NOTICE NO: - 12 of 2021

For and on behalf of the Lt. Governor UT of J&K, e-tenders are invited from the National/International registered Growers/Producers/Traders/Plant Material Importers having valid Import-Export Registration for Supply **of Good Quality Germplasm of different varieties of Tulip and other Bulbs** for ornamental purpose, as indicated in the detailed Book of Quantity (BOQ).

The bidding document(s) consisting of qualifying information, eligibility criteria, specification, terms and conditions and other details can be downloaded through the Departmental website www.dirflorikmr.in & www.jktenders.gov.in as per schedule of dates given below:-

In case of any eventuality, the date of opening will be considered on the next working day.

Terms and conditions: -

1. The required quantity of Germ Plasm is:
 - (i) Tulip Bulbs (700000 No's)
 - (ii) Hyacinth Bulbs (27000 No's)
 - (iii) Daffodil Bulbs (30000 No's)

The quantity/variety(ies) may increase or decrease subject to requirement and availability of funds.

2. Bids must be accompanied with cost of tender document Rs.2000/- (Rupees Two Thousand Only) (Non Refundable) in shape of **e-Challan, copy of receipt from Treasury** by crediting the requisite charges to the **MH-0406-Receipt of Forestry & Wild Life, Misc. Revenue (Public Gardens) or Demand Draft** favouring Accounts Officer, Department of Floriculture Kashmir indicating name of job/work.
3. In terms of EMD (Bid Security) in light of Circular issued by Financial Commissioner Finance Department UT of J & K vide No. A/Misc(2018)-III-895/J dated.22.12.2020- **No EMD is required**. However, the bidders are required to sign and upload bid security declaration as warranted under GFR-2017 Rule 170 (III) (**Annexure A**).

4. The Bidders/Firms having following documents shall be eligible for participation in the tender and shall have to upload these documents failing which bid shall be rejected: -
 - a. Registration Certificate of Growers/Producers/Traders/Plant Material Importers.
 - b. PAN card.
 - c. GSTIN Registration.
 - d. Copy of e-Challan/Demand Draft
 - e. Import Export code (IEC)
 - f. Latest copy of Income Tax Return
 - g. Experience/Documentary evidence for having supplied the item previously.
 - h. Adhaar Card
 - i. Bid Security Declaration Form (as per Annexure A)
5. The Successful bidder has to deposit Performance Security equal to @3% of the bid amount in the shape of Demand Draft/ Cash Certificate pledged to Department of Floriculture Kashmir within (02) days from the invitation from the authority, so that Contract is fixed & the same shall be released after successful completion of the job/Tulip show, certificate for which shall be issued by Floriculture Officer, Nehru Memorial Botanical Garden, Srinagar.
6. The successful bidder/firm(s) shall have to draw necessary agreement with the Department within 03 days from the date of issuance of the Contract and shall be required to submit signed copy of **Undertaking (Annexure B) as well.**
7. Rates for Germ plasm should be quoted in (IR) Indian rupee FOR Tulip Garden, Cheshmashahi, Srinagar UT of Jammu & Kashmir (India) inclusive of all the taxes & duties if applicable.
8. Conditional Tender will neither be entertained nor accepted.
9. The bidder/firm shall indicate the variety wise availability of Tulips.
10. The supplier shall have to submit Temperature and Humidity Sensor placed with the consignment during entire transit period from Holland/Netherlands (Origin Country) to India, UT of Jammu & Kashmir, Tulip Garden Srinagar at the time of delivery of the supply.
11. Supplier/firm shall have to furnish Phytosanitary /Quarantine Certificate for each imported consignment duly issued by the concerned Government authority of the origin.
12. Supply shall be subject to verification in respect of apparent disease or any other disorder by the constituted committee. Material not conforming to the tender specifications shall out rightly be rejected on the cost and risk of the supplier.
13. **80%** payment shall be released on receipt of supply/consignment as per specification provided in supply order and balance amount of **20%** retained in the shape of performance guarantee after observing the satisfactory performance, etc. of supplied material by the concerned Floriculture Officer.
14. Selection of Germplasm out of advertised varieties will be made after receiving and opening of tenders.

15. Purchase Committee reserves the right to accept or reject any or all tenders without assigning any reason thereof.
16. In case of any dispute arising during the currency of contract, the decision of the Divisional Level Purchase committee will be final and binding.
