- 1. Bids must be accompanied with cost of tender document in shape of e-challan/copy of receipt from Treasury favouring to Accounts Officer, Department of Floriculture Kashmir (Tender inviting authority) indicating name of job/work by crediting the requisite charges to the MH-o4o6-Receipt of Forestry & Wild life (Public Gardens) and earnest money/ Value of Security deposit in the shape of CDR/FDR pledged to Accounts Officer, Department of Floriculture Kashmir.
- 2. Rate should be quoted as per CFT inclusive of all the Taxes & duties for District indicates in concerned BOQ.
- 3. The tenderers/Firms should upload following documents otherwise tender shall be rejected:
 - a, Government Registration
 - b, PAN card,
 - c, GSTIN Registration.
 - d, Income Tax Return
 - e, Relevant CDR & e-Challan copy
- 4. The approved rates shall be valid for a period of one year from the date of issuance of the rate contract. The suppliers shall be received by the concerned strictly in accordance with the quality/specification as per terms and conditions of the concerned e-NIT
- 5. The purchase of material should be strict to the allotted/ availability of funds only without creating and liability.
- 6. Any CDR/FDR pending in the Department will not be accepted towards the current e-NIT.
- 7. Conditional tender shall not be entertained or accepted.
- 8. Successful tenderers shall have to enter into formal agreement deed with the department to on non judicial stamp paper under rules and in case failure in executing the agreement; the CDR shall not be released.

- 9. Successful tenderer /supplier of previous year shall have to obtain a satisfactory performance certificate /NOC from the concerned Drawing and Disbursing officers /order placing authority failing which their tender shall not be entertained.
- 10. Rate contract shall out rightly be rejected and replacement by the supplier on his own risk & cost without any additional charges.
- 11. Only the registered contractors/suppliers experienced in the job will be eligible for uploading tenders.
- 12. Un-casted CDR/FDR shall not be released.
- The CDR's of the un-successful contractors shall be released strictly after rate contract is fixed or, in case failure proper response or re-tender for supply, the CDR's will be released instantly.
- 14. For any dispute arising out during the currency of contract, decision of the Divisional Level Purchase committee shall be binding and final.
